

# CENTRAL VALLEY CHRISTIAN SCHOOLS Tuition and Fees 2010-2011



*The CVC school board is committed to finding a balance between providing the best Christian education for our children, and at the same time remaining sensitive to the cost.*

**Tuition** - Tuition costs for year 2010-2011 are as follows:

K-6 <sup>th</sup>	\$5817.00
7 <sup>th</sup> -8 <sup>th</sup>	\$6370.00
9 <sup>th</sup> -12 <sup>th</sup>	\$8145.00

**Matriculation Fee \$100** - For New students

A fee of \$100 (per student) must accompany the Application Form. The \$100 fee is non-refundable unless if there is not a space available for the child in his/her grade. Deadline for application is July 1, 2010.

\*Any application received on or after July 1<sup>st</sup> (the month before school begins) will be charged a \$200 Processing Fee. This includes the \$100 Matriculation Fee and a \$100 Late Application Fee.

**Testing Fee \$100-**

All incoming 1<sup>st</sup> through 12<sup>th</sup> grade students are required to take an entrance exam. The non refundable \$100 fee is due at the time of testing. Testing times are to be arranged through the admissions office.

**Registration Fee (\$100)**

For **returning students every year**, a Registration Fee of \$100 per student must be paid at the time of registration for the next year.

**\*\*\*Due to limited space, returning students must register by February 28, 2011 to guarantee enrollment.\*\*\***

**Early Withdrawal**

**Any student who withdraws anytime after July 1, 2010 will be charged tuition to the completion of the quarter in which the student is withdrawn.**

**Bus Service**

Regular bus service is offered to all students at no additional charge. This regular service requires students be brought to and picked up from a cluster stop.

**Payment Schedule**

**Plan #1** - 12 month - Twelve monthly payments beginning July 1, 2010; with final payment due June 1, 2011..

**Plan #2** - 10-month - Ten monthly payments beginning August 1, 2010; with final payment due May 1, 2011.

**Plan #3** - Quarterly - Four payments due August 1, 2010; November 1<sup>st</sup>, 2010; February 1<sup>st</sup>, 2011; and May 1, 2011.

**Plan #4** - Semi-Annual - The first payment due September 1, 2010; and the second payment due February 1, 2011.

**Plan #5** - Annual - Payment due on September 1, 2010.

**Delinquent Payments**

Tuition and fees are due the first of the month. Your account will be considered delinquent if payment is not received in the finance office by the 15<sup>th</sup> of the month following the due date. Delinquent tuition payments will be charged interest at 1 1/2 % per month. The responsible party will be notified of any amounts 60 days overdue. Students may not be enrolled if there is an outstanding balance from the previous school year.

**Discounts**

A 25% discount is available for pastors' who are employed full-time at their church and whose primary family income is derived from this pastor ship. Pastors' children must be accepted for enrollment and families approved prior to eligibility to receiving the tuition discount.

**Financial Aid**

Financial Aid may be available for those families previously enrolled who have difficulty paying full tuition. Communication with the Finance Office is encouraged if financial difficulties are experienced. The Finance Committee will review requests on an individual basis and provide aid as appropriate to the situation.
